The Education Sector, Dzongkhag Administration, Punakha would like to notify all the public that Pre-Primary Student Admission form for the academic year 2020 will be issued by the respective schools as mentioned below:

1. The form will be available from 15th November till 30th November during office hours.
2. PP Admission will be on 2nd December 2019 at schools.
3. Documents required for PP Admission are:
 - a) Copy of family tree record from census office issued by Ministry of Home & Culture Affairs/family tree census record issued by Gewog or G2C generated document that provide citizen details.
 - b) CID copy of father or mother.
 - c) Birth Certificate of a child.

Without above listed documents during the time of admission, the committee will not accept the admission as directed by Ministry of Education.

The admission will be conducted as per the notification No.DSE/SPCD/ADM(1.1) 2019/2084 dated 30th September,2019 of Director General, Ministry of Education.

Subject: Notification on Pre-Primary Student Admission 2020

Dear Dashos,

As you are all aware, as per the directives received vide letter No. P-08/1011 dated 17th July 2019 from the Hon'ble Lyonchen, the Ministry of Education has re-considered admission of those underage children in 2019 academic session as one time special consideration, on the ground that the students are already half way through the academic year. Accordingly, the Ministry has admitted the students by re-issuing the student code and updated in the EMIS.

However, in order to ensure smooth and timely admission in pre-primary (PP) and with objective and effort in streamlining admission in class PP as per the admission policy (to support child's physical, intellectual, language, emotional and social development) the Ministry of Education would like to once again notify to all schools to strictly follow the admission criteria for PP children vide circular No. 10 (1)-Edn/85/283585 dated 13th November 1985 for both public and private schools for the academic year 2020.

It is mandatory for all schools to note that all children attained age 6 (Six) as per the international calculation. Therefore, child born on or before 13th February 2014 at the start of the academic session shall be entitled for admission into Pre-Primary class. However, after all the eligible children have been admitted, if there is still space (maintaining the class/boarding capacities), schools have discretion to admit children of five and half years old or older (child born on or before 13th August 2014) at the start of the academic session.

The Ministry would also like to remind all schools to seek relevant document that validate the date of birth of the child as reflected in the Birth Certificate submitted (Family tree census record issued by Ministry of Home and Cultural Affairs/Family tree census record issued by Geog Office/G2C generated document that provide citizen detail).

Furthermore, kindly note that the Ministry of Education shall not be issuing Student Code for those children enrolled not as per the requirement. Should there be any issues with non-compliance to this notification, the school and the relevant officials shall be liable for administrative actions from the Ministry.

In this regard, we would like Dasho(s) to instruct the Dzongkhag/Thromde Education Officers to inform the concerned Primary School Principals to follow the admission criteria referring Advisory Note for
