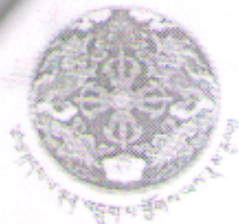
Dasho/Aum/Sir/Madam,

As a part of the Civil Service Reform initiatives, we are implementing the **Lifetime Civil Service Award for Civil/Public Servants** on the day of their superannuation to give due recognition of their service to the nation. In order to implement the award, as and when they gets superannuate, we are compiling the list of civil/public servants who will be superannuating with effect from **January 1, 2021 till December 31, 2021** and processing medals and certificates.

In this regard, we would like to request your agency to kindly submit the list of superannuating civil/public servants from **January 1, 2021 till December 31, 2021**. While submitting, we would like to request you to strictly observe the following points and also your nominations should be compiled as per the format attached herewith.

1. The nominee should serve a minimum of 20 years of service excluding EOL (if availed) at the time of his superannuation date.
2. Please do not forget to mention Contact Numbers (Mobile Number) of the nominees in the format provided. Nomination without contact detail will not be accepted.
3. CID number of the nominee is compulsory. Nominations without CID number will not be accepted and it will be included only upon produce of CID number.
4. Long-term training (LTT) obligation has been waived off, so you need not deduct the training period for the purpose of calculating of actual no. of service.
5. Adverse Record need not be verified because the criterion has been waived off.
6. Correct/full name of the nominees in Dzongkha against their English name should be provided as per the format attached.
7. Correct Designation of nominees should be submitted both in Dzongkha and English as per the format.
8. For the Public Service employee, if a nominee is civil servant before joining the public service, his/her services in the civil service will be counted for the actual number of his service, therefore, an evidence document (appointment order and separation order from civil service should be attached along with the list).
9. Nominations submitted not as per the format provided will not be accepted and the accountability will be on the respective agency.
10. If you have missed the 2019 Lifetime Civil Service Award for Civil/Public Servants please do submit now.

To implement the **Dedicated Service Award 2020**, the RCSC Secretariat would like to request your agency to kindly submit the list of nominations for the Dedicated Service Award for 10 years (Bronze medal & certificate), 20 years (silver medal & certificate) and 30 years (gold medal & certificate) respectively.

While submitting the nominations, we would like to request you to strictly observe the following points and also your nominations should be compiled as per the format attached herewith.

1. While compiling a list of nominations, please do not include those who have been already awarded the medals & certificate in the same category. For Example, if Mr. X has been already awarded bronze medal and

- certificate, he/she will not be eligible for the same category any more in his service period.
2. Please fill up EOL availed (days/months/years) to calculate "Actual No. of years served as of 30<sup>th</sup> June, 2020".
  3. Please do not forget to mention Contact Numbers (Mobile Number) of the nominees in the format provided. Nomination without contact detail will not be accepted.
  4. CID number of the nomination is compulsory. Nominations without CID number will not be accepted and it will be included only next year upon produce of CID number.
  5. Long-term training (LTT) obligation has been waived off, so you need not deduct the training period for the purpose of calculating of actual no. of service.
  6. Adverse Record need not be verified because the criterion has been waived off.
  7. Nominations for the award should be endorsed by the HR Committee and signed by Head of the agency and HR Officer. List without endorsement will not be accepted.
  8. Correct/full name of the nominees in Dzongkha against their English name should be provided as per the format attached.
  9. Correct Designation of nominees should be submitted both in Dzongkha and English as per the format.
  10. For the Public Service employee, if a nominee is civil servant before joining the public service, his/her services in the civil service will be counted for the actual number of his service, therefore, an evidence document (appointment order and separation order from civil service should be attached along with the list).
  11. Nominations submitted not as per the format provided will not be accepted and the accountability will be on the respective agency.
